

Homeownership Program Criteria Overview

Our program has certain requirements for future homeowners to ensure you become a successful first-time homeowner! To qualify, you must:

✓ **Afford a monthly mortgage.**

Our future homeowners need a middle credit score of **630**. They also need to meet the following income requirements to ensure your mortgage stays affordable for you:

✓ **Need access to a safe, affordable house.**

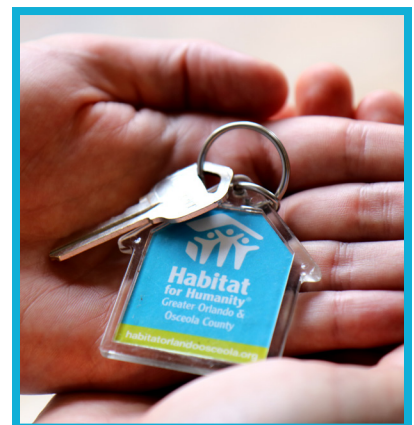

Ready to apply for Habitat Orlando & Osceola's Homeownership Program? Here's how:

Documents Checklist:

- Photo IDs for all household members ages 18 and over (government issued)
- Birth certificates
- Social Security cards
- Four most recent paystubs and end of year paystubs for last two years
- W2s for the last two years
- Tax returns for the last two years (signed)
- Bank statements for the last two months
- Retirement statements for the last quarter (if applicable)

STEP 1

Gather your documents.

You'll need to upload copies of some documents when submitting your official application. **Include copies for everyone who lives in your household.** A full list of required documents is shown to the left.

STEP 2

Pay application fee.

Visit HabitatOrlando.org/AppFee to submit the \$75 for a single applicant and \$150 for dual applicants nonrefundable application fee.

STEP 3

Check your email.

Once you pay your application fee, you'll get an email with the link to the homeownership application and instructions.

STEP 4

Fill out the application, upload all your documents, and submit.
